**RPI21/028 Arrow – Wells and Gathering Lines
RE: Non-compliance with requirement notice – Section 45(2)(b) *Regional Planning
Interests Act 2014*.**

I refer to your email dated 7 April 2022, with respect to your application for a regional interests development approval under the *Regional Planning Interests Act 2014* (RPI Act) for the Wells and Gathering Lines project associated with the Surat Gas Project.

Further to the requirement notice dated 5 October 2021 and the further requirement notice dated 27 October 2021 (the requirement notices) given for the application, an extension of time for the information under the requirement notices to be given to the Department of State Development, Infrastructure, Local Government and Planning (the department) was given to 5 April 2022.

Your email states that certain documents are provided in response to the requirement notices, and states that three plans required under the notice dated 5 October 2021 have not yet been finalised. You have advised that these plans will be provided as soon as they are finalised.

I am satisfied there is ongoing non-compliance with the requirement notice dated 5 October 2021, in that the following documents required under the notice have not yet been provided:

- erosion and sediment control plan
- subsidence management plan
- restoration management plan.

Please be advised that I have determined under section 45(2) of the RPI Act that the information sought under the requirement notice is to be provided in full, and that the application will not be decided until the requirement notice is complied with.

Please also be advised that public notification of the application is not to commence until all of the required information has been provided.
