## Requirement Notice

### RPI21/030 Santos – ZMT, Maya 2 and Wackett

*(given under section 44 of the Regional Planning Interests Act 2014)*

I refer to the assessment application which was properly made on 20 April 2022 under section 29 of the *Regional Planning Interests Act 2014* (RPI Act). The application is seeking a regional interests development approval (RIDA) to allow resource activities: petroleum and gas for the ZMT, Maya 2 and Wackett developments. The resource activities are proposed on Lot 1 SP133822 and Lot 1 SP209773 in the Channel Country Strategic Environmental Area (SEA).

## **Public notification requirement**

Pursuant to section 34(4) of the RPI Act, it has been determined that the application requires notification. The reason for the decision is that the delegate for the chief executive has determined that it is in the public interest for the application to be publicly notified.

In accordance with section 35 of the RPI Act, you are required to publish a notice about the application in the way prescribed in section 13 of the Regional Planning Interests Regulation 2014 (RPI Regulation) and give the owners of the land notice about the application.

Notification must commence within 20 business days after the application was made. The notification period is 15 business days, with the closing date being a day that is after the end of the notification period. 
